This year, 2022, saw the return of all State and national events. BQ introduced a new 8 A-Side event which was well received. Well done to all winners and participants in BQ's intrastate events in 2022. Thank you and well done to all host clubs and their volunteers for their valuable assistance in hosting/running these events: Broadbeach, Mermaid Beach, Club Musgrave, Club Helensvale, Paradise Point, Club Tweed, North Toowoomba, Toowoomba, Club Toowoomba, Club Manly, Suburban Townsville, Bargara, Chermiside, Northern Suburbs, Club Pine Rivers and Souths Suburban Mackay.

This will be an annual event together with our Open and Under 25 representative teams versus NSW. Congratulations to all bowlers who were selected to represent QLD throughout the past year in U18, U25, 40-59, O60, Open and disability events, also to those who were successful in winning medals or shields while representing. This was the inaugural year for "The Nationals" on the Gold Coast where Bowls Australia combined most of their events into a two-week block. This included a new National Physical Disability Championship.

The North versus South competition was well received once again with quality games being played.

The State Multi Disability Championships went well bringing together the four disability groups. The comradeship of these championships is amazing, well done to all involved in participating and to those who took home medals. The Secondary Schools Cup continues to grow and culminated in another great final series at Club Pine Rivers. Thank you to our RBMs for assisting with this event.

Well done to the clubs and their volunteers who held a day during our "Come and Try Month" in October or other months. BQ promoted the "Come and Try" month on social media throughout October, thank you to those who shared these posts.

Well done to our Australian representatives on an amazing performance in the 2022 Commonwealth Games and other international events throughout the year.

Peter Williamson and I attended biannual State Consultative Body meetings involving representatives from Bowls Australia and all State and territories who come together to discuss issues from across the nation.

Our online database continues to grow with more districts

and clubs going online in 2022. We encourage more to districts and clubs to contact Roxanne in the office to get online access to this valuable resource.

# Director of Finance Report

I have pleasure in once again presenting the financial report, this time for the year 2022.

A surplus of \$32,236 was achieved for the year ending December, 2022. This result was a decrease from the previous year when a surplus of \$125,941 was made. The main reason for the reduced surplus was because Covid 19 did not restrict Bowls Queensland implementing all its programs and events. Several events were cancelled last year which resulted in reduced competition expenses as compared with this year.

Revenue from all sources was up when compared to last year \$1,796,286 v \$1,718,912. Whilst revenue from affiliation fees declined during the year, income from some other sources were up when compared to last year. For 2022 Bowls Queensland saw an increase in income from the following revenue lines

- Sponsorship - up \$32,790
- Government Grants- up \$14,772
- Queensland Bowler Advertising Revenue- up \$6,708
- Interest Income - up \$19,071
- Competition Entry Fees – up \$2,354
- Other Income – up \$12,126

With regards to affiliation fee income this source of revenue has been in decline for several years because of declining club membership. Below is a five-year snapshot of the number of club members as at the 31st December of each year.

2018	2019	2020	2021	2022
28,840	27,277	26,435	25,801	24,238

This represents an average loss of 920 club members each year which impacts on the amount of affiliation fees collected. As 55% of affiliated

bowlers are over the age 70 the decline will most likely accelerate in coming years. This will put considerable pressure on the budget process.

Expenses for the year were up when compared to last year \$1,764,050 v \$1,592,971. Most of the difference was in relation to competition expenses which saw an increase of \$107,695. As mentioned above several events were cancelled last year due to Covid. This resulted in an underspend when compared to this year. Other expenses items were largely in line with budgeted predictions.

BQ is still in a good position to implement all its bowling programs without compromising the services it offers to members. Bowls Queensland has a very solid balance sheet and is well placed to meet the challenges that lay ahead.

Special thanks to Stuart Taylor, Finance Manager who has assisted me in this role throughout the year.

Best wishes to all board and committee members and the many volunteers who devote a lot of their time to this sport.

The general purpose financial report covers Bowls Queensland Limited ('the Company'). Bowls Queensland Limited is a non-for-profit Company limited by guarantee, incorporated and domiciled in Australia.

Comparatives are consistent with prior years, unless otherwise stated.

#### 1 Summary of Significant Accounting Policies

##### a Basis of Preparation

The financial statements are general purpose financial statements that have been prepared in accordance with the Australian Accounting Standards - Simplified Disclosure and the *Corporations Act 2001*.

The Group has adopted AASB 1060 General Purpose Financial Statements - Simplified Disclosures for For-Profit and Not-for-Profit Tier 2 Entities in the current year. Other than the change in disclosure requirements, the adoption of AASB 1060 has no significant impact on the consolidated financial statements because the Group's previous consolidated financial statements compiled with Australian Accounting Standards - Reduced Disclosure Requirements.

##### 2 Change in accounting policy

In the previous years, the directors prepared special purpose financial statements which complied with all recognition and measurement requirements.

In adopting this standard, the directors have applied AASB 1 *First Time Adoption Of Australian Accounting Standards*.

There were no effects on the prior year reported balances.

##### b Income Tax

The Company is exempt from income tax under Division 50 of the *Income Tax Assessment Act 1997*.

##### c Revenue and other income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the Company and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

All revenue is stated net of the amount of goods and services tax (GST).

##### Revenue from contracts with customers

The core principle of AASB 15 is that revenue is recognised on a basis that reflects the transfer of promised goods or services to customers at an amount that reflects the consideration the Company expects to receive in exchange for those goods or services. Revenue is recognised by applying a five-step model as follows:

1. Identify the contract with the customer
2. Identify the performance obligations

3. Determine the transaction price
4. Allocate the transaction price to the performance obligations
5. Recognise revenue as and when control of the performance obligations is transferred

Generally the timing of the payment for sale of goods and rendering of services corresponds closely to the timing of satisfaction of the performance obligations, however where there is a difference, it will result in the recognition of a receivable, contract asset or contract liability.

None of the revenue streams of the Company have any significant financing terms as there is less than 12 months between receipt of funds and satisfaction of performance obligations.

##### Specific revenue streams

The revenue recognition policies for the principal revenue streams of the Company are:

##### Affiliation fees

The Company earns revenue from provision of services to the clubs. Revenue is recognised over time in the accounting period when services are rendered.

The routine or recurring service contracts where the services provided are substantially the same, the consumption over time and whose consideration consists of a recurring fixed amount over the term of the contract (e.g. monthly or annual payment), in such a way that the customer receives and consumes the benefits of the services as the Company provides them, the revenue recognition model is based on the time elapsed output method.

Under this method, revenue is recognised on a straight line basis over the term of the contract and costs are recognised on an accrual basis

##### Government Grant

Where grant income arises from an agreement which is enforceable and contains sufficiently specific performance obligations then the revenue is recognised when control of each performance obligations is satisfied.

The performance obligations are varied based on the agreement but may include management of education events, presentations at symposiums and specific training courses. Each performance obligation is considered to ensure that the revenue recognition reflects the transfer of control and within grant agreements there may be some performance obligations where control transfers at a point in time and others which have continuous transfer of control over the life of the contract.

Where control is transferred over time, generally the input methods being either costs or time incurred are deemed to be the most appropriate methods to reflect the transfer of benefit.

###### **Interest revenue**

Interest is recognised using the effective interest method.

Donations and bequests are recognised as revenue when received.

###### **Subscriptions**

Revenue from the provision of membership subscriptions is recognised on a straight line basis over the financial year.

###### **Other income**

Other income is recognised on an accruals basis when the Company is entitled to it.

##### **d Goods and services tax (GST)**

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payable are stated inclusive of GST.

The net amount of GST recoverable from, or payable to, the ATO is included as part of receivables or payables in the statement of financial position.

Cash flows in the statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

##### **e Inventories**

Inventories are measured at the lower of cost and net realisable value.

##### **f Property, plant and equipment**

Each class of property, plant and equipment is carried at cost less, where applicable, any accumulated depreciation and impairment losses.

Where the cost model is used, the asset is carried at its cost less any accumulated depreciation and any impairment losses. Costs include purchase price, other directly attributable costs and the initial estimate of the costs of dismantling and restoring the asset, where applicable.

###### **Land and buildings**

Land and buildings are measured using the revaluation model.

###### **Plant and equipment**

Plant and equipment are measured using the cost model.

##### f Property, plant and equipment

###### Depreciation

Property, plant and equipment, excluding freehold land, is depreciated on a straight-line basis over the assets useful life to the Company, commencing when the asset is ready for use.

The depreciation rates used for each class of depreciable asset are shown below:

Fixed asset class	Depreciation rate
Buildings	7.5% prime cost - 40% diminishing value
Plant and Equipment	2.5% - 7.5% prime cost

At the end of each annual reporting period, the depreciation method, useful life and residual value of each asset is reviewed. Any revisions are accounted for prospectively as a change in estimate.

##### g Financial instruments

Financial instruments are recognised initially on the date that the Company becomes party to the contractual provisions of the instrument.

On initial recognition, all financial instruments are measured at fair value plus transaction costs (except for instruments measured at fair value through profit or loss where transaction costs are expensed as incurred).

###### Financial assets

All recognised financial assets are subsequently measured in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

###### Classification

On initial recognition, the Company classifies its financial assets into the following categories, those measured at:

- amortised cost
- fair value through profit or loss - FVTPL

Financial assets are not reclassified subsequent to their initial recognition unless the Company changes its business model for managing financial assets.

###### Amortised cost

Assets measured at amortised cost are financial assets where:

- the business model is to hold assets to collect contractual cash flows; and
- the contractual terms give rise on specified dates to cash flows are solely payments of principal and interest on the principal amount outstanding.

The Company's financial assets measured at amortised cost comprise trade and other receivables and cash and cash equivalents in the statement of financial position.

###### Financial assets

Subsequent to initial recognition, these assets are carried at amortised cost using the effective interest rate method less provision for impairment.

Interest income, foreign exchange gains or losses and impairment are recognised in profit or loss. Gain or loss on derecognition is recognised in profit or loss.

All financial assets not classified as measured at amortised cost or fair value through other comprehensive income as described above are measured at FVTPL.

Net gains or losses, including any interest or dividend income are recognised in profit or loss.

###### *Impairment of financial assets*

Impairment of financial assets is recognised on an expected credit loss (ECL) basis for the following assets:

- financial assets measured at amortised cost
- debt investments measured at FVOCI

When determining whether the credit risk of a financial assets has increased significant since initial recognition and when estimating ECL, the Company considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information and analysis based on the Company's historical experience and informed credit assessment and including forward looking information.

The Company uses the presumption that an asset which is more than 30 days past due has seen a significant increase in credit risk.

The Company uses the presumption that a financial asset is in default when:

- the other party is unlikely to pay its credit obligations to the Company in full, without recourse to the Company to actions such as realising security (if any is held); or
- the financial assets is more than 90 days past due.

Credit losses are measured as the present value of the difference between the cash flows due to the Company in accordance with the contract and the cash flows expected to be received. This is applied using a probability weighted approach.

###### *Trade receivables*

Impairment of trade receivables have been determined using the simplified approach in AASB 9 which uses an estimation of lifetime expected credit losses. The Company has determined the probability of non-payment of the receivable and multiplied this by the amount of the expected loss arising from default.

The amount of the impairment is recorded in a separate allowance account with the loss being recognised in

finance expense. Once the receivable is determined to be uncollectable then the gross carrying amount is written off against the associated allowance.

Where the Company renegotiates the terms of trade receivables due from certain customers, the new expected cash flows are discounted at the original effective interest rate and any resulting difference to the carrying value is recognised in profit or loss.

###### *Other financial assets measured at amortised cost*

Impairment of other financial assets measured at amortised cost are determined using the expected credit loss model in AASB 9. On initial recognition of the asset, an estimate of the expected credit losses for the next 12 months is recognised. Where the asset has experienced significant increase in credit risk then the lifetime losses are estimated and recognised.

###### Financial liabilities

The Company measures all financial liabilities initially at fair value less transaction costs, subsequently financial liabilities are measured at amortised cost using the effective interest rate method.

The financial liabilities of the Company comprise trade payables, bank and other loans and lease liabilities.

##### h Impairment of assets

At the end of each reporting period the Company determines whether there is an evidence of an impairment indicator for tangible and intangible assets. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs of disposal and value in use, is compared to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised immediately in profit and loss.

Where the future economic benefits of the asset are not primarily dependent upon the asset's ability to generate net cash inflows and when the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is determined as the depreciated replacement cost of an asset.

Where it is not possible to estimate the recoverable amount of a class of asset, the entity estimates the recoverable amount of the cash-generating unit to which the asset belongs.

Where an impairment loss on a revalued asset is identified, this is debited against the revaluation surplus in respect of the same class of asset to the extent that the impairment loss does not exceed the amount in the revaluation surplus for that same class of asset.

##### i Cash and cash equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

Bank overdrafts also form part of cash equivalents for the purpose of the statement of cash flows and are presented within current liabilities on the statement of financial position.

##### j Leases

At inception of a contract, the Company assesses whether a lease exists - i.e. does the contract convey the right to control the use of an identified asset for a period of time in exchange for consideration.

This involves an assessment of whether:

- The contract involves the use of an identified asset - this may be explicitly or implicitly identified within the agreement. If the supplier has a substantive substitution right then there is no identified asset.
- The Company has the right to obtain substantially all of the economic benefits from the use of the asset throughout the period of use.
- The Company has the right to direct the use of the asset i.e. decision making rights in relation to changing how and for what purpose the asset is used.

##### Lessee accounting

The non-lease components included in the lease agreement have been separated and are recognised as an expense as incurred.

At the lease commencement, the Company recognises a right-of-use asset and associated lease liability for the lease term. The lease term includes extension periods where the Company believes it is reasonably certain that the option will be exercised.

The right-of-use asset is measured using the cost model where cost on initial recognition comprises of the lease liability, initial direct costs, prepaid lease payments, estimated cost of removal and restoration less any lease incentives received.

The right-of-use asset is depreciated over the lease term on a straight line basis and assessed for impairment in accordance with the impairment of assets accounting policy.

The lease liability is initially measured at the present value of the remaining lease payments at the commencement of the lease. The discount rate is the rate implicit in the lease, however where this cannot be readily determined then the Company's incremental borrowing rate is used.

Subsequent to initial recognition, the lease liability is measured at amortised cost using the effective interest rate method. The lease liability is remeasured whether there is a lease modification, change in estimate of the lease term or index upon which the lease payments are based (e.g. CPI) or a change in the Company's assessment of lease term.

Where the lease liability is remeasured, the right-of-use asset is adjusted to reflect the remeasurement or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

##### *Exceptions to lease accounting*

The Company has elected to apply the exceptions to lease accounting for both short-term leases (i.e. leases with a term of less than or equal to 12 months) and leases of low-value assets. The Company recognises the payments associated with these leases as an expense on a straight-line basis over the lease term.

##### **k Employee benefits**

Provision is made for the Company's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled.

Employee benefits expected to be settled more than one year after the end of the reporting period have been measured at the present value of the estimated future cash outflows to be made for those benefits. In determining the liability, consideration is given to employee wage increases and the probability that the employee may satisfy vesting requirements. Cashflows are discounted using market yields on high quality corporate bond rates incorporating bonds rated AAA or AA by credit agencies, with terms to maturity that match the expected timing of cashflows. Changes in the measurement of the liability are recognised in profit or loss.

Employee benefits are presented as current liabilities in the statement of financial position if the Company does not have an unconditional right to defer settlement of the liability for at least 12 months after the reporting date regardless of the classification of the liability for measurement purposes under AASB 119.

##### **l Adoption of new and revised accounting standards**

The Company has adopted all standards which became effective for the first time at 31 December 2022, the adoption of these standards has not caused any material adjustments to the reported financial position, performance or cash flow of the Company.

##### **m Critical Accounting Estimates and Judgments**

The directors make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances.

These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates.

The significant estimates and judgements made have been described below.

##### **Key estimates - Impairment**

The Company assesses impairment at the end of each reporting period by evaluating conditions specific to the Company that may be indicative of impairment triggers. Recoverable amounts of relevant assets are reassessed using value-in-use calculations which incorporate various key assumptions.

##### **Key estimates - property held at fair value**

An independent valuation of the Enoggera property (land and buildings) carried at fair value was obtained as at 26 August 2020. The directors have reviewed and adopted this valuation prepared by Hymans Valuers and Auctioneers for the financial year ended 31 December 2020. The market value was determined using direct comparison with the available sales evidence within the surrounding locality.

##### **Key estimates - Provisions**

As described in the accounting policies, provisions are measured at management's best estimate of the expenditure required to settle the obligation at the end of the reporting period. These estimates are made taking into account a range of possible outcomes and will vary as further information is obtained.

##### Coorparoo Club House

On the 22 September 2009, the Company acquired the assets and liabilities of the Coorparoo Bowls Club for the nominal consideration on \$1. At that time, the Company commissioned Early Group Valuers to undertake a valuation of the property in order to reflect the value in the books of the Company. That valuation estimated the property to be worth \$3 million.

As a result, the Company recorded a revenue gain of \$3 million in the 2009 financial year. This is reflected in the retained earnings of the company.

In accordance with the Australian Accounting Standard, the Company has commissioned a valuation by Trivett Property Group as at 15 February 2019. That valuation has estimated the property to be worth \$1.9 million. This valuation was based on the property remaining a bowls club and does not reflect the possible value should the property be rezoned for either commercial or residential development.

# Umpire Committee's Report

A point of clarification for members, particularly new members, is that the law book is divided into two sections.

The first being the Laws for the Sport of Bowls. This section of the Law Book is the responsibility of World Bowls. World Bowls, through its association with member nations (Australia is a member nation), commence their deliberations approximately 12 months prior to the next Commonwealth Games. Once the deliberations are complete, member nations sign off on the revision at the relevant Commonwealth Games. In extraordinary circumstances there may be a revision during the four year period, but this is very rare.

The second section of the Law Book, referred to as the Domestic Regulations (DRs), is controlled by Bowls Australia. The DRs are reviewed after World Bowls has signed off on their section.

The revised law book that was agreed upon at the last Commonwealth Games should be released in the first quarter of 2023. The revised laws will take effect from 1 April 2023. I have been advised that some clubs are already utilising the new rules. This should not happen as they have not yet been released for use.

I regularly field questions about amendments/changes to the laws. Basically if it is not in a law book, the laws have not been amended.

One or two umpires from the committee attend most BQ events. We are approached for various matters, but mainly about the laws of the game and conditions of

play. We are only too pleased to answer any questions that may arise.

Members of the committee are available to attend any district to assist with accreditation or reaccreditation. The main criteria is that there are six or more participants for the course. There is no cost to the relevant district. We have received positive feedback from districts we've attended.

A lot of people do not wish to become umpires as it requires knowledge of the laws. If this is the case, then I strongly recommend that these people become measurers. Measurers are of great assistance to their clubs. The measurer's course comprises an ongreen test and a small tutorial. The entire course takes approximately five hours.

There will be courses this year for P & As and districts will be advised of these dates. BA has introduced a program for reaccrediting P & As, whereby the P & A is observed conducting a course. A copy of the program will be forwarded prior to the reaccreditation. A couple of the criteria are the P & A's communication skills and the items/material utilised during the course.

I would like to see at least one P & A in each district. The role of the P & A is to conduct the marker, measurer and umpire courses. This can be conducted over one weekend, over a number of days or over a series of evenings. Should anybody be interested please contact the umpire committee.

# Selection Committee's Report

Queensland representative teams performed extremely well in 2022 with success at the Nationals and in interstate test series against NSW and VIC.

Queensland's Open Men's team was outstanding, going through the Australian Sides Series undefeated (six wins and a draw) to win the Alley Shield for the first time since 2014. They also won the gold medal for the best performed men's rink. The Open Women's team won the silver medal with QLD finishing a close second to NSW for the overall trophy.

Queensland's U18 players were outstanding at the National Championships which saw Queensland receive the trophy for the best performed State overall, as well as best performed State (girls). Queensland also provided three girls and four boys to help make up two composite teams, making 17 Queensland juniors in total competing at the Nationals. Throughout the championships many coaches, managers and spectators commented on our players' respectful behaviour and their ability on the green, with gold medals being won by both the Queensland representative and Queensland composite teams.

The State Senior Women's side performed very well to win the silver medal. They won six out of their seven games with only a narrow 6 shot loss to Victoria keeping them out of the gold medal position. They also received the gold medal for the best performed women's rink.

The NSW Test Series held in August saw Queensland winning the Women's U25 shield and the inaugural Women's 40-59 shield. The Men's U25 test and the inaugural Men's 40-59 test were both drawn at one test apiece before weather stopped play with the shields being retained by NSW.

The Victoria test series held in conjunction with the Nationals saw both men and women's open teams retaining the shield for Queensland.
