Re: Protection of Umpires, Officials and Players

Ref: 23027

BACKGROUND:

Recently during a game of bowls an umpire was verbally abused. The question arises as to what immediate action is available to the umpire, an official or a player who is subjected to abuse.

ACTION:

Should an umpire, official or player be subjected to any offensive, abusive, threatening or intimidating language? The umpire on behalf of the official or player may take the action as defined in the Instantaneous Policy. A copy of the contents is attached for information.

The policy enhances the provisions of Law 13.4 contained in the Laws of the Sport of Bowls, Crystal Mark, edition 4.

Should the umpire take action against a player then umpire must complete the Instantaneous Penalty report and submit same to the controlling body and the State Authority within 7 days.

The State Authority then has the ability to initiate further action against the player.

INSTANTAENOUS PENALTIES POLICY

PRINCIPLE:

1. Bowls Australia (BA) believes in a fair and equitable competition and will do everything in its power to ensure that all players participate within the Laws of the Sport of Bowls. BA affiliated players undertake to conduct the game in a polite and sporting like manner when participating in any bowls event anywhere in Australia.

2. INSTANTANEOUS PENALTIES

- 2.1 If an umpire, by observation or on appeal by the Controlling Body, a side manager, a skip or an opponent, decides that a breach of any Law or Rule has taken place or any action by a player (where there is no penalty specified in that Law or Rule), such as:
 - 1. Acting in an abusive, threatening or intimidating manner;

- 2. Using obscene, offensive, abusive, threatening or intimidating language;
- 3. Threatening any person with physical violence or assault;
- 4. Assaulting any person; has occurred, then the end shall be immediately regarded as completed and the opponent of the offender shall be awarded as many shots as there are bowls in use by the opponent in a singles game, or opposing team in a team game, or team in a side game.
- 2.2 Upon a second such offence by the same player in the same game, the player shall be excluded from taking any further part in that game according to Laws of the Sport Crystal Mark, Version 4, April 2023.
- 2.3 Should this penalty be applied, no replacement or substitute player will be allowed for his/her team.
- 2.4 In a team game the defaulting team will forfeit the game to their opponent.
- 2.5 In a side game BA Domestic Regulations will apply.
- 2.6 A replacement player is not permitted for a singles player. BA Domestic Regulations will apply.
- 2.7 Serious offences may also be subject to police action. Consultation should occur between the venue manager, the Controlling Body and umpire/s before such action is undertaken.
- 2.8 The umpire must forward a detailed written report about any incident involving an instantaneous penalty to the Controlling Body and the relevant STA/s within seven (7) days of the incident.

DUTIES & RESPONSIBILITIES OF A CONTROLLING BODY

What is a Controlling Body?

The Controlling Body is the Match Committee of the Club/District or State/National running the event. If in the absence of a Controlling Body an appointed Delegate should be made by the Match Committee to act on their behalf during an event.

They must:-

- Be a financial Member of the Club.
- They must ensure the fair and equitable running of a lawn bowls match/event.
- Wear approved Club/District uniform when on duty.
- Have a written copy and reasonable knowledge of the Laws of the Sport of Bowls.
- Have a written copy and good knowledge of the Conditions of Play for the event in question.
- Have a current written copy of the Weather Policy/Guidelines and Uniform (Dress) Policy.
- Be responsible for the compilation of the Conditions of Play. Reference Appendix A of the Laws of the sport of Bowls Crystal mark 4th Edition.

Jurisdiction:

• For Club Championships and District Championships/Pennant, the respective Club/District Match Committee is the Controlling Body and they run these events on behalf of the State in accordance with the Conditions of Play issued.

IMPORTANT:

- (a) Where there is an interpretation of the law that is required, the controlling body must consult with an umpire.
- (b) There can be occasions when the Umpire of the day may seek a determination or assistance from the Controlling Body. **These examples may include.**
- The use of substitutes which requires the approval of the Controlling Body DR 2.1.3
- Matters related to the safety or damage to the green as set out in the Conditions of Play
- Matters related to heat and weather as per BQ Extreme Weather Policy
- Under Law 44.5 the Umpire may request the Controlling Body to act against a Coach who has breached the Law
- If a Spectator interferes in a game the Umpire may request the Controlling Body to act under Law 45.4

This means the Umpire of the day should not be the Controlling Body. Like the idea that an Umpire cannot be the Side Manager of the team on the green of which they are officiating. You should not be in a situation where a person would need to consult with themselves.

It would also be desirable to not only name and list the Umpire's of the day but to name the person who will be the Controlling Body for the day.
