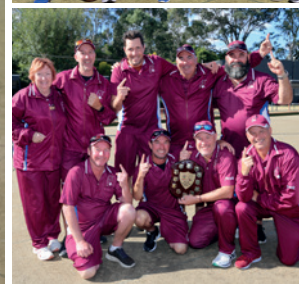

# President's Report

## Bowls Queensland (BQ) had major changes to the composition of the Board of Directors during 2024.

Wendy Wilson was appointed as a director in February to fill the casual vacancy following the sad passing of former director, Martin Corr. At the AGM in March, four directors were up for election, all four were opposed and all of the new candidates were elected: Brian Marshall (Vice President), Graham Lewis (Director of Finance), Alan Thorp (Director) and Joan Brotherton OAM (Director).

BQ President Peter Williamson tendered his resignation at the April board meeting and then in a series of meetings in May, the BQ Board finalised the following appointments: Brian Marshall (President), Wendy Wilson (Vice President) and Graham Tanis was appointed to fill the casual vacancy.

Welcome to all the new members of the BQ Board and to the only remaining board member from the previous year, Gary Costigan. Thank you for your time and effort during the remainder of the year in achieving many positive results for the sport.

Thank you to former board members: Peter Williamson (President), Kerry Green (Vice President), Greg Flynn (Director of Finance), Colleen Ryan (Director) and Carmel Gibb (Director) for their time devoted to filling these roles over many years.

With nearly a total new board came new ideas. One of the first to be implemented was a move to the whole of sport IT System BowlsLink. This system was used by Bowls Australia (BA) and all States and Territories other than BQ. Graham Lewis, BA and the BQ staff have done a wonderful job in rolling out this new system and are continuing to assist with this transition.

We agreed to review the BQ Constitution, By-laws, policies, operations, zones and events. A consultant was appointed to help assist with the Constitution and By-laws and recommendations will be presented to an Extraordinary Meeting of BQ.

After costing an extremely large amount of money over many years, it was agreed to stop the printing and postage of the Queensland Bowler Magazine, this will still be produced and distributed online only.



With the change to BowlsLink, and due to the cost and large amount of staff time involved, it was decided to stop producing the BQ Registered Member Cards.

A Zone Review was undertaken with no outcome resolved at this stage; this is an ongoing discussion regarding what will be best for the future. We will continue to consult with districts, clubs and key people in this area.

In regard to events, it was decided that due to the lack of support from many districts and clubs across the State, that the State 8 A-Side event be discontinued. Following a recommendation from the BQ Match Committee, the BQ Board endorsed that the State District Mixed Pairs event will now start at club level in 2025 with Club Mixed Pairs Champions progressing to a district play off as per Champion of Club Champion Singles, Pairs and Fours.

Open bowls and offerings for those who work or go to school during business hours have been an area we have been encouraging districts and clubs to consider when planning pennant and championships that progress onto higher level.

Many districts and clubs have been amalgamated in 2024 or are in the process. If you are not amalgamated already, I encourage you to look at how it has been done by others, learn from their experiences and consider this for the future.

Communication is high on the agenda of the new BQ Board, online meetings were introduced during 2024 for district presidents and secretaries to attend and have open discussion with the BQ Board and each other. These have proved valuable for all involved. We have also started running forums throughout the State to give districts and clubs the opportunity to attend and be updated by BQ and raise any ideas, issues or concerns. These too have proved to be popular.

I must thank all the BQ Committees for the work they have done in their respective areas, also to the staff at BQ for the hard work and dedication to the sport.

Thank you to all district and club administrators who devote their time to organising and promoting our great game of bowls, along with all the volunteers at clubs for their contribution at grass roots. We all need to work together to ensure a healthy future of the sport.

# CEO's Report

The Bowls Queensland (BQ) 2023 – 2025 Strategic Plan is nearing the end of its term. BQ has assisted Bowls Australia in the review of their plan and are now waiting for their document to be finalised. BQ will then work on a new plan for our future direction.

As mentioned in President Brian's report, there were major changes to the Board in 2024. The new Board were straight onto the front foot in reviewing how we operate, policies, constitution and events etc. I am excited to be a part of this new direction for our sport.

Thank you to Presidents Peter Williamson and Brian Marshall and all the Board of BQ for their commitment, leadership and vision. Thank you to all the hard-working members of BQ committees: Match, Umpires, Coaching, Selection and Audit & Risk; BQ could not operate without their tireless efforts. Also thank you to those who nominated for these committees and Board but were unsuccessful on this occasion.

BQ have introduced a new Junior Committee who met for the first time in October. This Committee will be looking at ideas to help promote and nurture junior bowling.

Thank you to our BQ Staff: Stuart Taylor – Finance Manager & Membership; Roxanne Bell – Operations Coordinator/Events; Cath Crowe – Operations Administrator and Micheal Sorrensen – Events & Competition Manager for their ongoing hard work and dedication. Bill Cornehl was appointed as Events, Competition & High-Performance Manager during the year before resigning due to family reasons. Roxanne is transitioning into retirement by reducing her days worked late in the year before using up all her accumulated leave over 24 years. Roxanne has played an integral part of BQ since its inception and also with the RQBA prior to that. Roxanne will notch up 25 years of working in both of these organisations in March 2025 prior to her retirement scheduled for soon after.

The BQ AGM and Council Meetings held in March and September were productive meetings with many great topics discussed. Thank you to all delegates who make the journey to these meetings.

Thank you to Cornerstone Communications Jo Grey and Dee Ayre for producing a quality QLD Bowler magazine.

Our Bowls Australia Club Support Managers (CSMs) were busy travelling our State throughout the year, thank you to David Barnes in Central QLD, Micheal Sorrensen in Southeast QLD (who resigned in August), his replacement Troy Corba (who started in December) and also NT's Paul Jackson who assisted clubs in North QLD throughout the year.

BowlsLink has been a great addition with much staff time reduced with efficiencies created. We nearly have all clubs signed up with club administrator access for BowlsLink. We encourage more clubs to contact Stuart in the office to get online access to this valuable resource. Many clubs and districts are using this system for their competitions with great feedback so far.

BQ received advice from IP Australia that our new trade mark logo was officially approved and registered. Due to this advice, the Board agreed to start transitioning over to this new logo. Initially, digital assets such as letterheads, email tags, website, live streaming and social media etc will bear the new logo. Other physical assets like uniforms and promotional material will change in the future as per the need to replace.

Thank you to the QLD State Government for continuing their support of bowls in QLD through their Active Industry Base Funding, Active Industry Project Funding, women/girls in sport funding and grants for clubs and districts.

Thank you to our Commercial Partners who have supported Bowls in QLD for many years: Mullins Lawyers, BCIB, Aceit, J Carroll Club Promotions and BioScapes Group.

Peter Williamson, Brian Marshall and I attended State Consultative Body Meetings involving representatives from Bowls Australia and all State / Territories who come together to discuss issues from across the Nation.

Well done to all winners and participants in BQ's intrastate events in 2024. Thank you and well done to

all host clubs and their volunteers for their valuable assistance in hosting/running these events, trials or camps: Club Musgrave, Broadbeach, Club Helensvale, Paradise Point, Club Tweed, Bargara, Capalaba Sports, Club Pine Rivers, Souths Suburban Mackay, Burnett, Across the Waves, Chermside, Northern Suburbs, Enoggera, Hamilton, Southport, Club Robina, Benowa, Mermaid Beach and Mudgeeraba.

An QLD Under 18 camp and trials for our various QLD teams took place which was a great opportunity for all involved. BQ reintroduced Squads for QLD representative teams in Open, Under 25, 40-59 and Over 60 categories, well done to all selected in these Squads. Congratulations to all bowlers who were selected to represent Queensland in U18, U25, 40-59, O60, open and disability events, also to those who were successful in winning medals or shields while representing. This was the inaugural year for an Under 18 Tri Series involving NSW and Victoria. The Nationals were held at Club Tweed and Broadbeach (both were great hosts) with all our teams and players performing well. Thank you to our team managers/coaches. Thank you to ACEIT for producing quality uniforms for our representative players and officials.

Well done to our Australian representatives and squad members for amazing performances in 2024.

BQ partnered up with QLD Representative School Sport to enter a team in the School Sport Australia Championships for the first time.

The North versus South competition was held in Mackay for the second time and was well received, well done to all players involved in this event.

The State Multi Disability Championships went well bringing together the four disability groups. The comradeship of these championships is amazing, well done to all involved in participating and to those who took home medals. The Secondary Schools Cup continues to grow and culminated in another great final's series at Club Pine Rivers. Thank you to our CSMs for assisting with this event.

Well done to the clubs and their volunteers who held a day during our "Try Bowls" Month in October or other months. BQ promoted the "Try Bowls" month on social media throughout October, thank you to those who shared these posts.

Unfortunately, we had more clubs affected by weather events in 2024, BQ offered assistance through their Disaster Relief Fund and liaised with clubs/Government regarding assistance available. Clubs affected included Stratford, Cooktown, Mareeba, Tully and Paradise Point.

Well done to all volunteers in their roles at clubs and districts administering the sport throughout Queensland and Northern NSW.

The future of our sport requires the whole bowling community to play a part in promoting our game to family/friends/local community and volunteering their time where possible to either spread the word or assist in your local club and/or district.

I am enjoying working with our current board with new ideas and direction, I look forward to another busy and productive year in the role of CEO working with all stakeholders to administer our sport. Let's all work together to promote and nurture this great game of ours.

# Director of Finance Report

As forecast at the September Council meeting, a deficit has been reported. This was higher than forecast due largely in part to a change in reporting procedures as directed by the auditors.

Total revenue increased 4.1%. Affiliation fee income represents 67.2% of total income.

Historically, member numbers have been decreasing year on year, however the introduction of BowlsLink has revealed a level of non-disclosure of members which would suggest that the decline is not as drastic as once thought.

The current affiliation fee model would appear to not meet the needs of Bowls Queensland or its members and is being reviewed by the BQ Board in conjunction with Bowls Australia. It is envisaged that the Board will have more details mid-2025.

Interest rates remained high, reflecting favourable returns on term deposits. Ongoing expense of the Bowler Magazine, bad debts incurred in 2023 and written off in 2024, Coorparoo Bowls Club and additional un-budgeted expenses relating to the Nationals all impacted negatively on the bottom line.

The introduction of BowlsLink was also over and above what was budgeted for. The investment in BowlsLink was partially offset by savings of ongoing maintenance and development of the now decommissioned BQ database.

Upon taking office the BQ Board embarked on a review of the business which again was an un-budgeted item, however one that the Board believed was extremely important and necessary.

Initially the review focused on short-term objectives, however, it has become apparent that a more in-depth analysis will be required.

BQ's Balance Sheet is very solid, and we are well placed to fulfill all our bowling programs as well as undertake the business review and any findings that may come out of it.

My predecessor Mr. Greg Flynn is to be congratulated for his tireless efforts over many years and for our current financial position.

I thank our Finance Manager, Stu Taylor, for his unwavering dedication and support he has provided for myself and the new Board. His commitment to the BowlsLink Membership rollout has been outstanding.

Thanks also to CEO Brett Wilkie and my fellow board members for their efforts and contributions.

Finally, a very big thank you to all the club officials and BowlsLink Administrators. Your contribution has ensured that the BowlsLink Membership rollout was successful and on time.



The general purpose financial report covers Bowls Queensland Limited ("the Company"). Bowls Queensland Limited is a non-for-profit Company limited by guarantee, incorporated and domiciled in Australia.

Comparatives are consistent with prior years, unless otherwise stated.

#### 1 Summary of Material Accounting Policies

##### a Basis of Preparation

The financial statements are general purpose financial statements that have been prepared in accordance with the Australian Accounting Standards and the *Corporations Act 2001*.

The Company has adopted AASB 1060 General Purpose Financial Statements - Simplified Disclosures for For-Profit and Not-for-Profit Tier 2 Entities in the current year.

##### b Income Tax

The Company is exempt from income tax under Division 50 of the *Income Tax Assessment Act 1997*.

##### c Revenue and other income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the Company and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

All revenue is stated net of the amount of goods and services tax (GST).

Revenue from contracts with customers

The core principle of AASB 15 is that revenue is recognised on a basis that reflects the transfer of promised goods or services to customers at an amount that reflects the consideration the Company expects to receive in exchange for those goods or services. Revenue is recognised by applying a five-step model as follows:

1. Identify the contract with the customer
2. Identify the performance obligations
3. Determine the transaction price
4. Allocate the transaction price to the performance obligations
5. Recognise revenue as and when control of the performance obligations is transferred

Generally the timing of the payment for sale of goods and rendering of services corresponds closely to the timing of satisfaction of the performance obligations, however where there is a difference, it will result in the recognition of a receivable, contract asset or contract liability.

##### c Revenue and other income

###### Revenue from contracts with customers

None of the revenue streams of the Company have any significant financing terms as there is less than 12 months between receipt of funds and satisfaction of performance obligations.

###### Specific revenue streams

The revenue recognition policies for the principal revenue streams of the Company are:

###### Affiliation fees

The Company earns revenue from provision of services to the clubs. Revenue is recognised over time in the accounting period when services are rendered.

The routine or recurring service contracts where the services provided are substantially the same, the consumption over time and whose consideration consists of a recurring fixed amount over the term of the contract (e.g. monthly or annual payment), in such a way that the customer receives and consumes the benefits of the services as the Company provides them, the revenue recognition model is based on the time elapsed output method.

Under this method, revenue is recognised on a straight line basis over the term of the contract and costs are recognised on an accrual basis

###### Government Grant

Where grant income arises from an agreement which is enforceable and contains sufficiently specific performance obligations then the revenue is recognised when control of each performance obligations is satisfied.

The performance obligations are varied based on the agreement but may include management of education events, presentations at symposiums and specific training courses. Each performance obligation is considered to ensure that the revenue recognition reflects the transfer of control and within grant agreements there may be some performance obligations where control transfers at a point in time and others which have continuous transfer of control over the life of the contract.

Where control is transferred over time, generally the input methods being either costs or time incurred are deemed to be the most appropriate methods to reflect the transfer of benefit.

###### Interest revenue

Interest is recognised using the effective interest method.

Donations and bequests are recognised as revenue when received.

###### Subscriptions

Revenue from the provision of membership subscriptions is recognised on a straight line basis over the financial year.

###### Other income

Other income is recognised on an accruals basis when the Company is entitled to it.

##### d Goods and services tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payable are stated inclusive of GST.

The net amount of GST recoverable from, or payable to, the ATO is included as part of receivables or payables in the statement of financial position.

Cash flows in the statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

##### e Inventories

Inventories are measured at the lower of cost and net realisable value.

##### f Property, plant and equipment

Each class of property, plant and equipment is carried at cost less, where applicable, any accumulated depreciation and impairment losses.

Where the cost model is used, the asset is carried at its cost less any accumulated depreciation and any impairment losses. Costs include purchase price, other directly attributable costs and the initial estimate of the costs of dismantling and restoring the asset, where applicable.

###### Land and buildings

Land and buildings are measured using the revaluation model.

###### Plant and equipment

Plant and equipment are measured using the cost model.

###### Depreciation

Property, plant and equipment, excluding freehold land, is depreciated on a straight-line basis over the assets useful life to the Company, commencing when the asset is ready for use.

The depreciation rates used for each class of depreciable asset are shown below:

Fixed asset class	Depreciation rate
Buildings	7.5% prime cost - 40% diminishing value

##### f Property, plant and equipment

At the end of each annual reporting period, the depreciation method, useful life and residual value of each asset is reviewed. Any revisions are accounted for prospectively as a change in estimate.

##### g Financial instruments

Financial instruments are recognised initially on the date that the Company becomes party to the contractual provisions of the instrument.

On initial recognition, all financial instruments are measured at fair value plus transaction costs (except for instruments measured at fair value through profit or loss where transaction costs are expensed as incurred).

##### Financial assets

All recognised financial assets are subsequently measured in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

##### *Classification*

On initial recognition, the Company classifies its financial assets into the following categories, those measured at:

- amortised cost
- fair value through profit or loss - FVTPL

Financial assets are not reclassified subsequent to their initial recognition unless the Company changes its business model for managing financial assets.

##### *Amortised cost*

Assets measured at amortised cost are financial assets where:

- the business model is to hold assets to collect contractual cash flows; and
- the contractual terms *give* rise on specified dates to cash flows are solely payments of principal and interest on the principal amount outstanding.

The Company's financial assets measured at amortised cost comprise trade and other receivables and cash and cash equivalents in the statement of financial position.

Subsequent to initial recognition, these assets are carried at amortised cost using the effective interest rate method less provision for impairment.

Interest income, foreign exchange gains or losses and impairment are recognised in profit or loss. Gain or loss on derecognition is recognised in profit or loss.

All financial assets not classified as measured at amortised cost or fair value through other comprehensive income as described above are measured at FVTPL.

##### Financial assets

Net gains or losses, including any interest or dividend income are recognised in profit or loss.

##### *Impairment of financial assets*

Impairment of financial assets is recognised on an expected credit loss (ECL) basis for the following assets:

- financial assets measured at amortised cost
- debt investments measured at FVOCI

When determining whether the credit risk of a financial assets has increased significant since initial recognition and when estimating ECL, the Company considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information and analysis based on the Company's historical experience and informed credit assessment and including forward looking information.

The Company uses the presumption that an asset which is more than 30 days past due has seen a significant increase in credit risk.

The Company uses the presumption that a financial asset is in default when:

- the other party is unlikely to pay its credit obligations to the Company in full, without recourse to the Company to actions such as realising security (if any is held); or
- the financial assets is more than 90 days past due.

Credit losses are measured as the present value of the difference between the cash flows due to the Entity in accordance with the contract and the cash flows expected to be received. This is applied using a probability weighted approach.

##### *Trade receivables*

Impairment of trade receivables have been determined using the simplified approach in AASB 9 which uses an estimation of lifetime expected credit losses. The Company has determined the probability of non-payment of the receivable and multiplied this by the amount of the expected loss arising from default.

The amount of the impairment is recorded in a separate allowance account with the loss being recognised in finance expense. Once the receivable is determined to be uncollectable then the gross carrying amount is written off against the associated allowance.

Where the Company renegotiates the terms of trade receivables due from certain customers, the new expected cash flows are discounted at the original effective interest rate and any resulting difference to the carrying value is recognised in profit or loss.

###### Financial assets

Impairment of other financial assets measured at amortised cost are determined using the expected credit loss model in AASB 9. On initial recognition of the asset, an estimate of the expected credit losses for the next 12 months is recognised. Where the asset has experienced significant increase in credit risk then the lifetime losses are estimated and recognised.

###### Financial liabilities

The Company measures all financial liabilities initially at fair value less transaction costs, subsequently financial liabilities are measured at amortised cost using the effective interest rate method.

The financial liabilities of the Company comprise trade payables, bank and other loans and lease liabilities.

##### h Impairment of assets

At the end of each reporting period the Company determines whether there is an evidence of an impairment indicator for tangible and intangible assets. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs of disposal and value in use, is compared to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised immediately in profit and loss.

Where the future economic benefits of the asset are not primarily dependent upon the asset's ability to generate net cash inflows and when the company would, if deprived of the asset, replace its remaining future economic benefits, value in use is determined as the depreciated replacement cost of an asset.

Where it is not possible to estimate the recoverable amount of a class of asset, the Company estimates the recoverable amount of the cash-generating unit to which the asset belongs.

Where an impairment loss on a revalued asset is identified, this is debited against the revaluation surplus in respect of the same class of asset to the extent that the impairment loss does not exceed the amount in the revaluation surplus for that same class of asset.

##### i Cash and cash equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

Bank overdrafts also form part of cash equivalents for the purpose of the statement of cash flows and are presented within current liabilities on the statement of financial position.

##### j Leases

At inception of a contract, the Company assesses whether a lease exists - i.e. does the contract convey the right to control the use of an identified asset for a period of time in exchange for consideration.

This involves an assessment of whether:

- The contract involves the use of an identified asset - this may be explicitly or implicitly identified within the agreement. If the supplier has a substantive substitution right then there is no identified asset.

##### j Leases

- The Company has the right to obtain substantially all of the economic benefits from the use of the asset throughout the period of use.
- The Company has the right to direct the use of the asset i.e. decision making rights in relation to changing how and for what purpose the asset is used.

##### Lessee accounting

The non-lease components included in the lease agreement have been separated and are recognised as an expense as incurred.

At the lease commencement, the Company recognises a right-of-use asset and associated lease liability for the lease term. The lease term includes extension periods where the Company believes it is reasonably certain that the option will be exercised.

The right-of-use asset is measured using the cost model where cost on initial recognition comprises of the lease liability, initial direct costs, prepaid lease payments, estimated cost of removal and restoration less any lease incentives received.

The right-of-use asset is depreciated over the lease term on a straight line basis and assessed for impairment in accordance with the impairment of assets accounting policy.

The lease liability is initially measured at the present value of the remaining lease payments at the commencement of the lease. The discount rate is the rate implicit in the lease, however where this cannot be readily determined then the Company's incremental borrowing rate is used.

Subsequent to initial recognition, the lease liability is measured at amortised cost using the effective interest rate method. The lease liability is remeasured whether there is a lease modification, change in estimate of the lease term or index upon which the lease payments are based (e.g. CPI) or a change in the Company's assessment of lease term.

Where the lease liability is remeasured, the right-of-use asset is adjusted to reflect the remeasurement or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

##### *Exceptions to lease accounting*

The Company has elected to apply the exceptions to lease accounting for both short-term leases (i.e. leases with a term of less than or equal to 12 months) and leases of low-value assets. The Company recognises the payments associated with these leases as an expense on a straight-line basis over the lease term.

##### k Employee benefits

Provision is made for the Company's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled.

Employee benefits expected to be settled more than one year after the end of the reporting period have been measured at the present value of the estimated future cash outflows to be made for those benefits. In determining the liability, consideration is given to employee wage increases and the probability that the employee may satisfy vesting requirements. Cashflows are discounted using market yields on high quality corporate bond rates incorporating bonds rated AAA or AA by credit agencies, with terms to maturity that match

##### l Critical Accounting Estimates and Judgments

The directors make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances.

These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates.

The significant estimates and judgements made have been described below.

##### Key estimates - Impairment

The Company assesses impairment at the end of each reporting period by evaluating conditions specific to the Company that may be indicative of impairment triggers. Recoverable amounts of relevant assets are reassessed using value-in-use calculations which incorporate various key assumptions.

##### Key estimates - property held at fair value

An independent valuation of the Enoggera property (land and buildings) carried at fair value was obtained as at 26 August 2020. The directors have reviewed and adopted this valuation prepared by Hymans Valuers and Auctioneers for the financial year ended 31 December 2020. The market value was determined using direct comparison with the available sales evidence within the surrounding locality.

An independent valuation of the Coorparoo property (land and buildings) carried at fair value was obtained as at 13 December 2023. The directors have reviewed and adopted this valuation prepared by Hymans Valuers and Auctioneers for the financial year ended 31 December 2023. The market value was determined using direct comparison with the available sales evidence within the surrounding locality.

##### Key estimates - Provisions

As described in the accounting policies, provisions are measured at management's best estimate of the expenditure required to settle the obligation at the end of the reporting period. These estimates are made taking into account a range of possible outcomes and will vary as further information is obtained.

#### Coorparoo Club House

On the 22 September 2009, the Company acquired the assets and liabilities of the Coorparoo Bowls Club for the nominal consideration on \$1. At that time, the Entitmissioned Early Group Valuers to undertake a valuation of the property in order to reflect the value in the books of the Company. That valuation estimated the property to be worth \$3 million.

As a result, the Company recorded a revenue gain of \$3 million in the 2009 financial year. This is reflected in the retained earnings of the company.

In accordance with the Australian Accounting Standard, the Company has commissioned a valuation by Trivett Property Group as at 15 February 2019. That valuation has estimated the property to be worth \$1.9 million. This valuation was based on the property remaining a bowls club and does not reflect the possible value should the property be rezoned for either commercial or residential development.

An independent valuation of the Coorparoo property (land and buildings) carried at fair value was obtained as at 13 December 2023. The directors have reviewed and adopted this valuation prepared by Hymans Valuers and Auctioneers for the financial year ended 31 December 2023. The market value was determined using direct comparison with the available sales evidence within the surrounding locality. The valuation of the property has estimated it to be worth \$2.57 million.

##### Enoggera Property

On the 13 August 2020, the Company acquired land Lot 10 located at 72 Pickering St. Enoggera QLD for \$715,000 plus transaction costs. On 26 August 2020, an independent valuation carried by Hymans Valuers and Auctioneers of the Enoggera property was obtained. The market value was determined using direct comparison with the available sales evidence within the surrounding locality. That valuation has estimated the property to be worth \$2.25 million. As a result, the Company recorded a revaluation adjustments of \$1.29 million in the 2020 financial year. This is reflected in other comprehensive income for the year 2020 and revaluation reserve of the company

# Coaching Committee's Report

In 2024 the State Coaching Committee had a busy year, but not as busy as 2023. I attribute this slow start to a consequence of the slow uptake of grants being offered for coaches/umpires to visit specific remote areas throughout Queensland to provide Coaching and Officiating courses.

Eleven districts were visited with many different coaching activities being provided at a number of clubs throughout the State. Some districts were visited more than once during 2024, depending on demand. Activities were conducted in more than 45 clubs during the year.

This year, 200+ bowlers attended Skills/Bowling Arm days under the guidance of Presenters and Assessors (P&As) from Bowls Queensland. The numbers were down for 2024 but are expected to increase in 2025.

More than 60 bowlers were reaccredited, and it will be interesting to see how many will continue to reaccredit if and when the new coach pathways are adopted and introduced by Bowls Australia. The number of bowlers accrediting at club

and introductory coaches was above the 2023 figures with an increase of around 25 members making the total 136. Included in this number are a few bowlers who opted to do the Bowls Australia on-line course which then requires a P&A from BQ to complete the course. This involves an on-green assessment, totalling around six hours, which has caused significant delays between the two components of the course. The demographics in Queensland make this method of delivery in its current format totally inadequate, as bowlers lose interest in becoming a coach due to lengthy delays.

Having conducted some of these courses over the last 14 months with Dennis O'Toole, the time that members looked at completing the on-green component (sometimes longer than five months) rendered the participants as totally unprepared. They had forgotten the majority of the on-line component which made the revision period extremely long and very time consuming.

The recommendation from the State Coaching Committee for it to be a success in Queensland, a period of no longer than four weeks must be enforced between the two components. This undoubtedly will lend itself to courses being more expensive and less demanding if the pathways are enforced by Bowls Australia. Common sense as outlined with demographics only highlights this problem.

There were many other activities conducted during the year which included coach's workshops, selection and competition modules and State Coaching Committee (SCC) members working with Junior Development programs.

On a number of occasions, SCC members were required to work with State sides as coaches or team managers and this was a great initiative by Bowls Queensland.

Unfortunately, no coaches nominated to form a Sub Committee to the State Coaching Committee in 2024, which posed a very heavy workload on the six SCC members. Hopefully, this year some coaches may like the experience of working at the State level and nominate. The main requirement to be a member of either of the committees, is that you become an accredited P&A at the time of nomination or be willing to undertake

the training. I am happy to announce that Geoff Campbell from the Sunshine Coast District, Kawana Bowls Club, has been invited to join the State Coaching Committee and we welcome Geoff on board as he brings a lot of experience and knowledge to the table. Welcome Geoff. At this moment I am also in the process of finding other suitable candidates for either committee roles and hopefully I can encourage others to come on board.

Toward the end of the year we lost the services of Eric Tomsene who after 40+ years of coaching decided it was time to retire. Eric did an exceptional amount of work on the Sunshine Coast and other areas through out Queensland for a number of years as member of the SCC. I personally thank him for his dedication and loyalty and we all wish him the very best for the future.

As the Medical Classifier in Queensland for the physically impaired and a member of the classifying team with Dennis O'Toole and Tony Bonnell, we have classified a number of athletes for disability bowls in 2024. I envisage for this to continue with the exposure and opportunities being provided by the Gold Coast Tweed and Moreton Bay Districts plus live streaming about para bowls and other athletes with disabilities including the Life Stream and Hearing Impaired. I expect the number of requests for classification to rise substantially in the next few years. Finally, the development of the Youth High Performance Academy has been exceptional in the second year under the guidance of Lynsey Clarke from BA with the Academy offering a tremendous opportunity for those young bowlers who are fortunate enough to gain entry.

In closing, I would like to thank all members of the SCC committee and BQ Board for all their the hard work and the staff who look after the administration aspects for us. Thank you Cath, Stu, Roxanne, Brett, and Jo, editor of the Bowler.

All in all it has been a rewarding year and the Coaching Committee look forward to providing many coaching activities to members in 2025.

# Umpire Committee's Report

I would like to express my thanks to members of the committee for their assistance and guidance throughout the last year.

When requesting a law interpretation of a general query relating to the laws, please check with your local umpire committee. If not satisfied with the response, then forward same to the BQ Umpire committee. A simple query that was received related to the length of the roll of the jack: Is it 21 or 23 metres? This could very easily be answered locally.

The new P&A Facilitator's Guide has been dispatched from Bowls Australia. In the near future, courses will resume for the reaccreditation of current P&As. We are still chasing a couple of P&As for various locations throughout Queensland. BA has forwarded a format in which they require all P&A reaccreditations to occur. There is only one criteria, which is that umpires who wish to become a P&A have at least four years experience and a sound knowledge of the laws of the game. This is not an arduous undertaking; however, requires a face-to-face meeting at a course being conducted. I am making inquiries if this can be done electronically.

The committee is prepared to attend any district without a P&A to conduct umpire courses. We would like at least six people willing to undertake the course. This is at no cost to the relevant district, other than the relevant application cost when players apply to undertake the course. The only criteria is that any person wishing to undertake the relevant course/s have at least two years' experience.

An issue has arisen in a couple of districts and clubs on 'conditions of play'. To go out on a limb, I would guess that there are a number of clubs throughout the State that do not have any conditions of play for their competitions, making a ruling on the run if something happens. To give an example, the duration of a game is contained in the conditions of play with the number of ends that constitute a game.

To complete a set of conditions of play, I recommend going to the Bowls Queensland website and looking at the conditions of play for various events. The relevant club can then modify those conditions of play to suit its respective competitions. If a club or district wish the BQ Umpire Committee to review its conditions of play, please forward them to us and we will return them with suggestions as soon as possible.

At the last meeting in September, I made mention that if there are players, clubs or districts that wish to have law either introduced or reviewed, please forward this to us with supporting documentation.

# Risk & Policy Committee's Report (previously Audit & Risk Committee)

As a result of a review of the Bowls Queensland Finance Policy and the introduction of improved controls on the use of company credit cards, the Board agreed to remove the audit role of this committee and renamed it as the Risk and Policy Committee.

The Board adopted a minimalistic Risk Appetite Statement and conducted a detailed Risk Assessment in accordance with the principles of AS/NZS ISO 31000:2018, assessing all relevant risks and implementing appropriate risk mitigation where appropriate. The revised Policy and Risk Register will be reviewed annually.

As part of the Risk Assessment, it was noted that many of the existing Bowls Queensland Policies had not been reviewed for many years, a significant departure from good governance.

The introduction of the National Integrity Framework has had a significant impact on some Policies and the Board has instructed this committee to review all BQ policies. This is a work in progress, expected to be completed by June 2025.

# Selection Committee's Report

Selectors attended all major State events during 2024 to assess current State team and State squad members, as well as players who have submitted an EOI for State representative selection, and to identify new and emerging talent.

The benefit of selectors watching events that draw players from across all districts in the State is reflected in the opportunities being offered to these players, particularly in attending state trials, selection to teams for the North vs South Challenge, or selection to State squads and teams.

## State Squads

The decision by BQ to name State squads for 2024 was very well received by players. Players named in squads meet all the criteria for state representative selection. A player may be selected to one or more squads or added to a squad during the year.

## U18 Squad

2024 was seen as a development year for our U18 squad with 11 of the 16 players making their representative debuts. Highlights for the Junior squad in 2024 included a two-day training camp in April at Hamilton Bowls Club and U18 tri-series against NSW and VIC in August at Club Tweed. The School Sport Australia Championships at Geelong in September was another highlight, where QLD won one gold, two silver and an overall team bronze medal. Two players were named in the All Australian Schools Lawn Bowls team and have the opportunity to represent in either a QLD or QLD/NSW composite team at the Australian U18 championship.

## QLD v NSW test series July, St Johns Park, NSW

This was the final selection event for the VIC test/ Australian Sides Championships. QLD won 2 of the 6 series played, including U25 Women, and 40-59 Men. QLD v VIC test series September, Tweed Heads, QLD Changes were made to both men and ladies open teams following their defeat by NSW in July, with new players coming into the side and positional changes made. The Women's and Men's teams won their respective series against VIC 3-0.

## THE NATIONALS October, Gold Coast Tweed

U18 QLD boys' team won the Boys' Overall Best State Trophy with gold medal performance from the boy's fours and silver from both the boy's triples and pairs. The U18 girls came away with silver in the singles and bronze in the triples. QLD finished 3rd overall. The composite side won silver in the girl's fours and bronze in the boy's fours. The QLD Para team took out the overall best performed State for the third year in a row at the Para nationals. At the Australian Senior Sides, QLD women's senior side claimed the silver medal. QLD women won gold, the Marj Morris Trophy and the gold medal for the best performed rink at the Australian Sides Championships, while QLD men claimed the silver medal for the second year in a row.

QLD men and women won the NT test series (played during the Nationals) 3-0.

## NORTH v SOUTH November, Souths Suburban Mackay

South ladies won the series 2-1 and regained the shield won by the North ladies in 2023. The South Men won the series 3-0 in a close contest.

I would like to thank Brett, Roxanne, Bill and the rest of the Bowls Queensland staff for their assistance throughout the year and to the selection committee Ron, Kurt, Wendy, Gary and Brad (up until July) for giving up a considerable amount of their own time to assess and evaluate players, manage teams and attend major events.

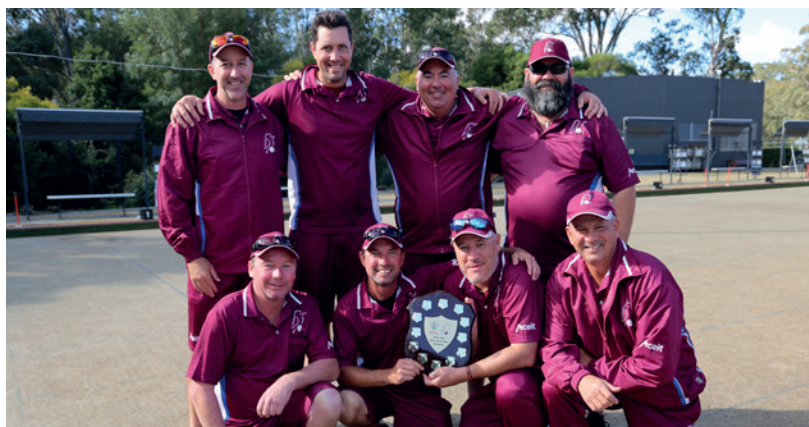

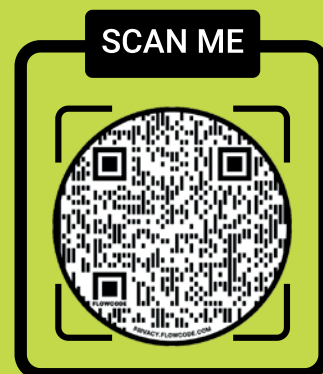
